Our Welcoming Resolution says exactly that.

Councilor Gordon says, “Our police follow state and federal law, no more and no less, and *in Randolph it’s safe for immigrants to talk to our police.*” The Town Police Chief echoed that long-standing policy, in a recording that has been blocked from RCTV. “Our police don’t do MORE than the law requires – they’re not ICE Deputies and they never will be – and our police don’t do LESS than the law requires – we’re not a Sanctuary City,” adds Councilor Gordon.
